What is the project about?

Project location

The facility will be developed at the Institute premises on Kilimanjaro Road, Upper Hill.

Project cost

The total project cost is approximately Kes. 20,000,000 divided into 2,000 Governance Blocks each costing Kes. 10,000.

Is the project the same as CPS Governance Center Ltd?

The CPS Governance Center Ltd. was a public limited company incorporated to act as a commercial investment vehicle where members were to buy shares.

This project is an institute initiative council for members to give their voluntary contributions to build training facilities at the institute premises and we are fundraising through donations.
